**DIRECTIONS FOR USE:** **CABRIO® 25 ND** should only be applied in a spray program with other fungicides (e.g. Calixin™ 86 OL and OpaI™ 7.5 EC) used in banana to control Sigatoka and freckles.

CROP	DISEASE	DOSE RATE (L/HA)	APPLICATION INTERVAL
Corn	Leaf Spot	0.4	V7 - V10 leaf stage of corn (approximately 35-60 DAP)
Banana	Sigatoka Freckles	0.4	12 - 14 days

**MIXING:** For Corn, 1) Add 30% of the total water to the knapsack sprayer, 2) Add the recommended rate of **CABRIO® 25 ND** at 40 mL/16 L of water, then agitate; and 3) Add the rest of the water to complete the total volume. The spray volume for corn is 160 liters per hectare. For Banana, the recommended mixing procedures for **CABRIO® 25 ND** are as follows: 1) Add banana oil plus recommended rate of emulsifier, then agitate; 2) Add 50% of total water, then agitate; 3) Add the recommended rate of **CABRIO® 25 ND**, then agitate; and 4) Add the rest of the water to complete the total volume.

**COMPATIBILITY:** **CABRIO® 25 ND** is compatible with banana oil (e.g. Banole) and other commonly used fungicides in banana (e.g. OpaI™ and Calixin™ ). **PRE-HARVEST INTERVAL:** 4 days. **RE-ENTRY PERIOD:** After drying of spray.

**STORAGE AND DISPOSAL:** Store in original container, tightly closed, away from food and feed by storage or disposal. Triple rinse container, then offer for recycling, or puncture and dispose off in a sanitary landfill.
